


Product Diagram (F35023-USB-EXTENDER)





Transmitter (Local Extender)

1. Connect the **USB Micro B Host Port** to a **USB-A Port** on the **Host Computer**, using the included **USB Type A to USB Micro B Cable**.

No drivers are needed for the USB Extender Over Fiber.

2. Connect a **LC to LC Multimode Fiber Cable** to the **SFP Fiber Slot** located on the **Transmitter**.

The fiber cable should not go through any networking equipment (e.g. router, switch, etc.).

2. Connect the included **Power Adapter** to an **Electrical Outlet** and into the **DC Power Port** of the **Receiver**.
3. Connect a **USB Peripheral Device** to any of the two **USB-A Peripheral Ports** on the **Receiver**.

Some USB peripheral devices may need drivers to finish their installation.
