使用環境および快適に使用するために

ワイヤレスWANカードは、ほかの無線装置のように無線周波数電磁波を發します。しかしながら、これらの無線装置が發する電磁波が人体へ与える影響は、頭部等へ直接接觸して使用される携帯電話などの機器とは異なり、とても弱いレベルのものです。
