## Daily maintenance of the product

- Avoid direct sunlight
- Avoid high temperatures and humidity
- Avoid being near open flames
- Keep away from hard objects, avoid knocking, and do not scratch.
- The device's exterior may be cleaned using a moist or soft cloth.
- It is recommended to charge once a month if not in use for an extended period of time and keep the battery fully charged when using

## Troubleshooting Instructions

If the product is not working properly, please check for the following conditions. If our suggestions do not solve the problem, please return the product to the dealer for repair.

## Product Disposal Precautions
