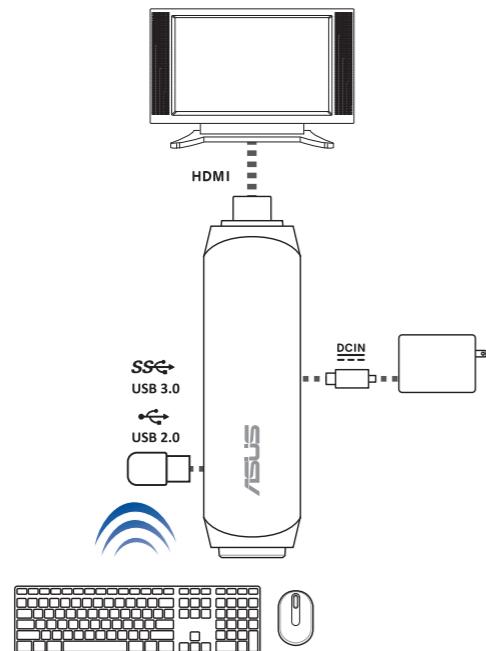

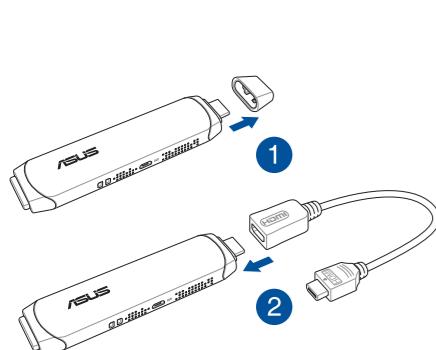

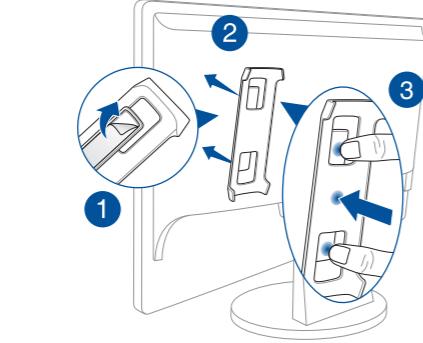
Connecting HDMI extension cable and VivoStick Holder

Connecter le câble d'extension HDMI au support VivoStick



1. Remove the cap, then connect your HDMI extension cable.

Retirez l'embout, puis connectez le câble d'extension HDMI.



2. Ensure the adhesive is firmly placed on the back of the VivoStick Holder, then stick your VivoStick Holder to your monitor and firmly press it in place.

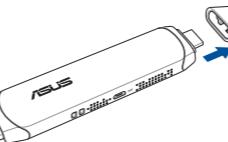
- Ensure that the air vents on your VivoStick are not blocked or else overheating may occur. Use the VivoStick Holder to prevent blocking the air vents.
- Place your VivoStick or powered USB hub near the side of your monitor to ensure that wireless signals are not obstructed.
- Use the USB 2.0 port to connect external devices to maintain the quality of your wireless connections.
- Use wireless keyboard and mouse for a better user experience. USB hub, keyboard and mouse are for reference only and not included.
- Any peripheral over 500 mA (USB 2.0) or 900 mA (USB 3.0) current draw should be connected via a powered USB hub, and not directly to the USB port.
- For best performance, operate at 1°C (33.8°F) – 35°C (95°F).

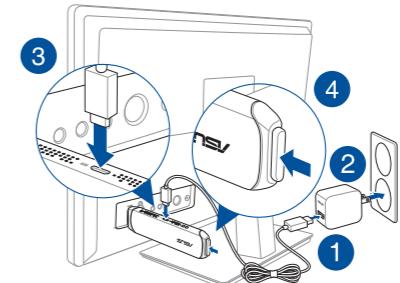

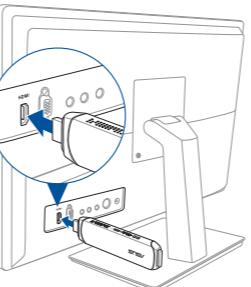

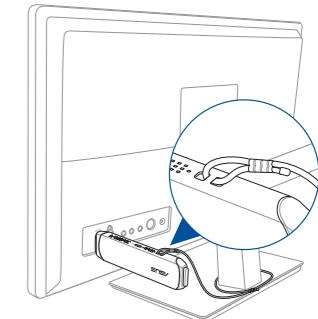

Safety information

Your VivoStick is designed and tested to meet the latest standards of safety for information technology equipment. However, to ensure your safety, it is important that you read the following safety instructions.

Setting up your system

- Read and follow all instructions in the documentation before you operate your system.
- Do not use this product near water or a heated source.
- Make sure you leave plenty of space around the system for ventilation.
- Use this product in environments with ambient temperatures between 1°C (33.8°F) and 35°C (95°F).
- If you use an extension cord, make sure that the total ampere rating of the devices plugged into the extension cord does not exceed its ampere rating.
- If you notice any of the following conditions (or if you have other safety concerns), do not use your device: crackling, hissing, popping sound, or a strong odor or smoke coming from your device.
