Do not leave your ASUS Tablet and ASUS Mobile Dock on your lap or near any part of your body to prevent discomfort or injury from heat exposure.

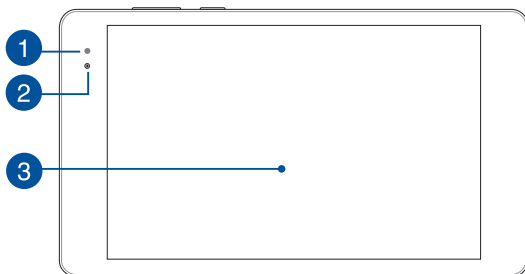

# ASUS Tablet

The ASUS Tablet allows you to perform touch screen gestures while working on Windows® 10.

## Front View



### 1 Ambient light sensor

The ambient light sensor detects the amount of ambient light in your environment. It allows the system to automatically adjust the brightness of the display depending on the ambient light condition.

### 2 Front camera

The built-in 2-megapixel front camera allows you to take pictures or record videos using your ASUS Tablet.

### 3 Touch screen panel

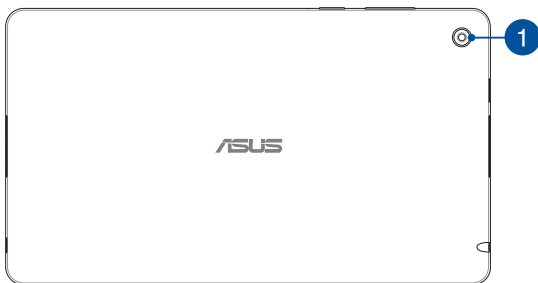
This high-definition touch screen panel provides excellent viewing features for photos, videos, and other multimedia files on your ASUS Tablet. It also allows you to operate your ASUS Tablet using touch gestures.

---

**NOTE:** To know more about using touch screen gestures when operating your ASUS Tablet, refer to the *Gestures for the touch screen panel* section in this manual.

---

## Back view



### 1 Rear camera

The built-in rear camera allows you to take pictures or record videos using your ASUS Tablet.

## Top View



### 1 Volume button

The volume button allows you to increase or decrease the volume level of your ASUS Tablet.

### 2 Power button

Press the power button to turn your ASUS Tablet on, put it to sleep mode, and wake it up from sleep mode.

In the event that your ASUS Tablet becomes unresponsive, press and hold the power button for at least four (4) seconds to force it to Shut down.

---

**IMPORTANT!** Forcing the system to restart may result to data loss. We strongly recommend that you back up your data regularly.

---

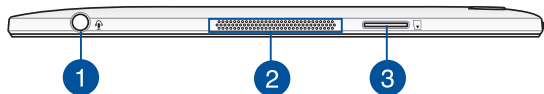


### 3 Two-color battery charge indicator

The two-color LED provides a visual indication of the battery's charge status. Refer to the following table for details:

Color	Status
<b>Solid White</b>	The ASUS Tablet is plugged to a power source and the battery power is between 95% and 100%.
<b>Solid Orange</b>	The ASUS Tablet is plugged to a power source, charging its battery, and the battery power is less than 95%.
<b>Blinking Orange</b>	The ASUS Tablet is running on battery mode and the battery power is less than 10%.
<b>Lights off</b>	The ASUS Tablet is running on battery mode and the battery power is between 10% to 100%.

## Left side



1

### **Headphone/Headset/Microphone jack**

This port allows you to connect your tablet to amplified speakers or headphones. You can also use this port to connect your tablet to an external microphone.

2

### **Audio speakers**

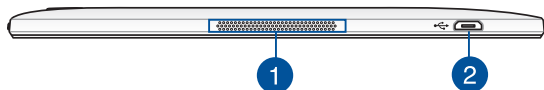
The built-in audio speakers allow you to hear audio straight from your tablet. Audio features are software controlled.

3

### **MicroSD card slot**

This ASUS Tablet comes with a built-in memory card reader slot that supports microSD, microSDHC and microSDXC card formats.

## Right side

### Audio speakers

The built-in audio speakers allow you to hear audio straight from your tablet. Audio features are software controlled.

2

### Micro USB 2.0 port

This micro USB (Universal Serial Bus) 2.0 port is compatible with USB 2.0 or USB 1.1 devices such as keyboards, pointing devices, flash disk drives, external HDDs, speakers, cameras and printers.

You may also insert the bundled power adapter into this port to charge the battery pack and supply power to your ASUS Tablet.

**WARNING!** The adapter may become warm to hot while in use. Do not cover the adapter and keep it away from your body while it is connected to a power source.

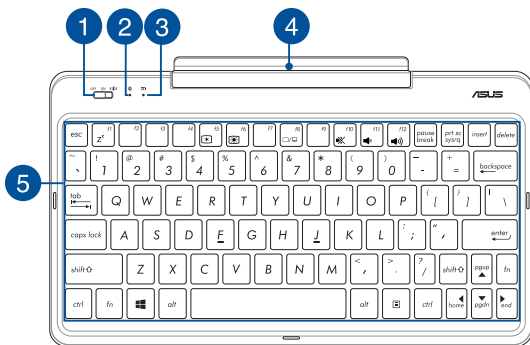

# ASUS Mobile Dock features

## Top view



### 1 **ASUS Mobile Dock power switch / Bluetooth switch**

Move this switch to the right or to the left to turn on or turn off your ASUS Mobile Dock and its Bluetooth connectivity.

### 2 **Bluetooth indicator**

This indicator lights up when your ASUS Mobile Dock's Bluetooth is enabled.

### 3 Two-color battery charge indicator

The two-color LED provides a visual indication of the battery's charge status. Refer to the following table for details:

Color	Status
<b>Solid White</b>	The ASUS Mobile Dock is plugged to a power source and the battery power is between 95% and 100%.
<b>Solid Orange</b>	The ASUS Mobile Dock is plugged to a power source, charging its battery, and the battery power is less than 95%.
<b>Blinking Orange</b>	The ASUS Mobile Dock is running on battery mode and the battery power is less than 10%.

#### 4 **ASUS Mobile Dock hinge**

This hinge allows you to connect the tablet to the keyboard dock. It also holds the tablet in place as you adjust it to different viewing angles.

#### 5 **Keyboard**

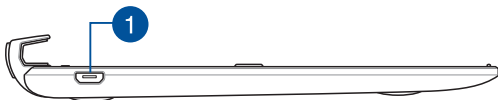
The keyboard provides full-sized QWERTY keys with a comfortable travel depth for typing. It also enables you to use the function keys, allows quick access to Windows®, and controls other multimedia functions.

**NOTE:** The keyboard layout differs by model or region.

## Left view



### 1 Micro USB 2.0 port

You may also insert the bundled power adapter into this port to charge the battery pack and supply power to your ASUS Mobile Dock.

# Getting started

## ASUS Tablet

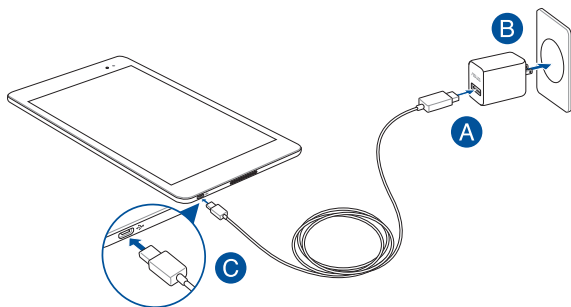
### Charging your ASUS Tablet

- A. Connect the micro USB cable to the power adapter.
- B. Plug the power adapter into a grounded power outlet.
- C. Plug the micro USB connector into your ASUS Tablet.

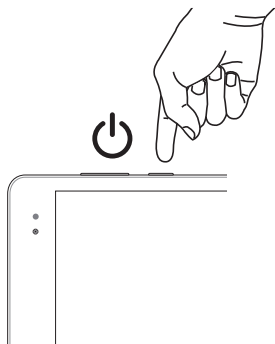

**NOTE:** The power adapter may vary in appearance, depending on models and your region. Use only the bundled power adapter for charging.

---



## Powering on your ASUS Tablet



---

### IMPORTANT!

- Locate the input/output rating label on your ASUS Tablet and ASUS Mobile Dock and ensure that it matches the input/output rating information on your power adapter. Some ASUS Tablet and ASUS Mobile Dock models may have multiple rating output currents based on the available SKU.
  - Ensure that your ASUS Tablet and ASUS Mobile Dock is connected to the power adapter before turning it on for the first time. We strongly recommend that you use a grounded wall socket while using your ASUS Tablet and ASUS Mobile Dock on power adapter mode.
  - The socket outlet must be easily accessible and near your ASUS Tablet and ASUS Mobile Dock.
  - To disconnect your ASUS Tablet and ASUS Mobile Dock from its main power supply, unplug your ASUS Tablet and ASUS Mobile Dock from the power socket.

---

**IMPORTANT!**

Power adapter information:

- Input voltage: 100-240Vac
  - Input frequency: 50/60Hz
  - Rating output current: 2A
  - Rating output voltage: 5V
- 

**NOTES:**

- Risk of explosion if battery is replaced by an incorrect type.
  - Dispose of used battery according to the instructions.
- 

Ensure to fully charge the battery before using your ASUS Tablet and ASUS Mobile Dock for extended periods. Remember that the power adapter charges the battery as long as it is plugged into a power source. Be aware that it takes much longer to charge the battery when your ASUS Tablet and ASUS Mobile Dock is in use.

---

**IMPORTANT!** Do not leave your ASUS Tablet and ASUS Mobile Dock connected to the power source once it is fully charged. Your ASUS Tablet and ASUS Mobile Dock is not designed to be connected to the power source for extended periods of time.

---

## The battery

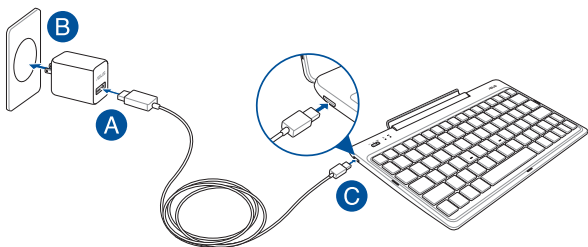
Your ASUS Tablet and ASUS Mobile Dock is equipped with a high performance non-detachable Li-Ion battery. Observe the maintenance guidelines for a longer battery life.

- Do not remove the non-detachable Li-ion battery as this will void the warranty.
- Avoid charging in extremely high or low temperature. The battery performs optimally in an ambient temperature of +5 °C to +35 °C.
- Do not remove and replace the battery with a non-approved battery.
- Do not remove and soak the battery in water or any other liquid.
- Never try to open the battery as it contains substances that might be harmful if swallowed or allowed to come into contact with unprotected skin.
- Do not remove and short-circuit the battery, as it may overheat and cause a fire. Keep it away from jewelry or metal objects.
- Do not remove and dispose of the battery in fire. It could explode and release harmful substances into the environment.
- Do not remove and dispose of the battery with your regular household waste. Take it to a hazardous material collection point.
- Do not touch the battery terminals.

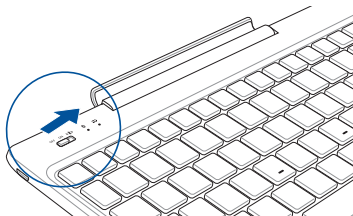

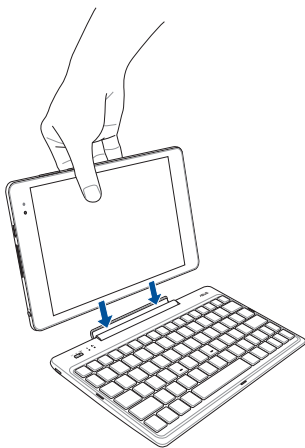

## Using your ASUS Tablet with the ASUS Mobile Dock

Refer to the following steps if you want to use both your ASUS Tablet and ASUS Mobile Dock as a Notebook PC.

1. Ensure that both devices are charged.
2. Dock the ASUS Tablet into the ASUS Mobile Dock as shown in the illustration below.



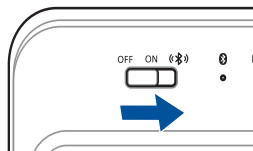
3. Turn on each device to enable automatic Bluetooth pairing.


## Pairing your ASUS Mobile Dock with the ASUS Tablet

You may use your ASUS Mobile Dock to wirelessly connect with your ASUS Tablet via Bluetooth pairing.

Pairing is done automatically between both devices. In case Bluetooth pairing becomes disrupted, refer to the following steps to manually re-enable it.

1. Turn on your ASUS Mobile Dock and its Bluetooth function by pressing the switch all the way to the right.



2. Turn on the Bluetooth feature of your ASUS Tablet.
3. Launch the **Charms bar**.
4. Tap/click  then tap/click **Change PC Settings**.
5. Under **PC Settings**, select **Devices** then tap/click **Add a Device** to search for **ASUS T90CHI DOCKING** under the list of Bluetooth devices for pairing, then select it.



# Gestures for the touch screen panel

Gestures allow you to launch programs and access the settings of your ASUS Tablet. Refer to the following illustrations when using hand gestures on your touch screen panel.

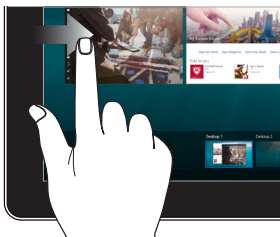

## Using touch screen panel gestures

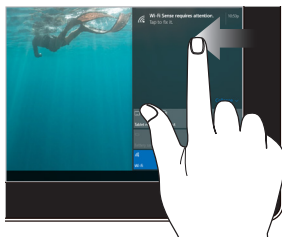

### Left edge swipe



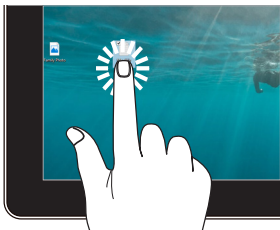
Swipe from the left edge of the screen to launch **Task view**.

### Right edge swipe



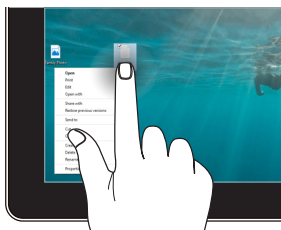
Swipe from the right edge of the screen to launch **Action Center**.

## Tap/Double-tap



- Tap an app to select it.
- Double-tap an app to launch it.

## Press and hold



Press and hold to open the right-click menu.

## Zoom in



Spread apart your two fingers on the touch screen panel.

## Zoom out



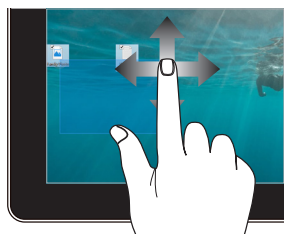
Bring together your two fingers on the touch screen panel.

## Finger slide



Slide your finger to scroll up and down and slide your finger to pan the screen left or right.

## Drag



- Drag to create a selection box around multiple items.
- Drag and drop an item to move it to a new location.

# Using the keyboard

## Function keys

The function keys on your keyboard can trigger the following commands:



Puts the ASUS Tablet into **Sleep mode**



Decreases display brightness



Increases display brightness



Toggles the display mode

Turns the speaker on or off



Turns the speaker volume down



Turns the speaker volume up

# Starting for the first time

When you start your computer for the first time, a series of screens appear to guide you in configuring your Windows® 10 operating system. The Windows® 10 operating system is bundled within your ASUS Tablet.

To start for the first time:

1. Turn on your ASUS Mobile Dock (if applicable) and ASUS Tablet. Wait for a few minutes until the setup screen appears.
2. From the setup screen, pick your region and a language to use on your ASUS Tablet.
3. Carefully read the License Terms. Select **I accept**.
4. Follow the onscreen instructions to configure the following basic items:
  - Personalize
  - Get online
  - Settings
  - Your account
5. After configuring the basic items, Windows® 10 proceeds to install your apps and preferred settings. Ensure that your ASUS Tablet is kept powered on during the setup process.
6. Once the setup process is complete, the Start screen appears.

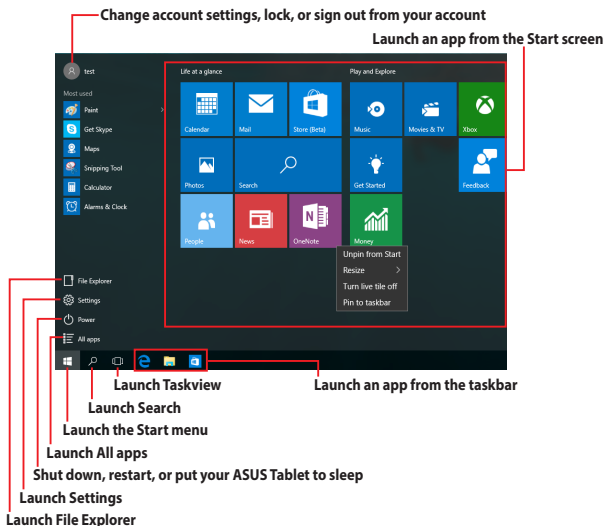

# Start menu

The Start menu is the main gateway to your ASUS Tablet's programs, Windows® apps, folders, and settings.



You can use the Start menu to do these common activities:

- Start programs or Windows® apps
- Open commonly used programs or Windows® apps
- Adjust ASUS Tablet settings
- Get help with the Windows operating system
- Turn off your ASUS Tablet
- Log off from Windows or switch to a different user account

## Launching the Start menu



Tap the Start button  in the lower-left corner of your desktop.



Press the Windows logo key  on your keyboard.

## Opening programs from the Start menu

One of the most common uses of the Start menu is opening programs installed on your ASUS Tablet.



Tap the program to launch it.



Use the arrow keys to browse through the programs.

Press  to launch it.

---

**NOTE:** Select **All apps** at the bottom of the left pane to display a full list of programs and folders on your ASUS Tablet in alphabetical order.

---

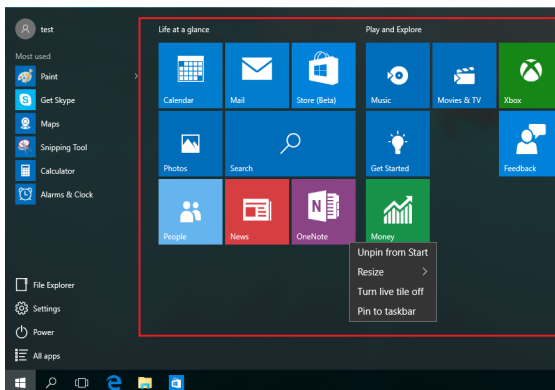
# Windows® apps

These are apps pinned on the right pane of the Start menu and displayed in tiled-format for easy access.

---

**NOTE:** Some Windows® apps require signing in to your Microsoft account before they are fully launched.

---



## Working with Windows® apps

# Hardware FAQs

**1. A black dot, or sometimes a colored dot, appears onscreen when I turn on the ASUS Tablet. What should I do?**

Although these dots normally appear onscreen, they will not affect your system. If the incident continues and subsequently affects system performance, consult an authorized ASUS service center.

**2. My display panel has an uneven color and brightness. How can I fix this?**

The color and brightness of your display panel may be affected by the angle and current position of your ASUS Tablet. The brightness and color tone of your ASUS Tablet may also vary per model. You may use the function keys or the display settings in your operating system to adjust the appearance of your display panel.

**3. How can I maximize my ASUS Tablet's battery life?**

You can try doing any of the following suggestions:



- Use the function keys to adjust the display brightness.
- If you are not using any Wi-Fi connection, switch your system into **Airplane mode**.
- Disconnect unused USB devices.
- Close unused applications, especially those that take up too much system memory.

**4. My battery charge indicator does not light up. What's wrong?**

- Check whether the power adapter or battery pack is attached correctly. You may also disconnect the power adapter or battery pack, wait for a minute, then reconnect them again to the power outlet and ASUS Tablet.
- If the problem still exists, contact your local ASUS service center for assistance.

**5. When I play audio and video files, why can't I hear any sound from my ASUS Tablet's audio speakers?**




You can try doing any of the following suggestions:

- Press  +  to turn up the speaker volume.

## Internal Modem Compliance

The ASUS Tablet with internal modem model complies with JATE (Japan), FCC (US, Canada, Korea, Taiwan), and CTR21. The internal modem has been approved in accordance with Council Decision 98/482/EC for pan-European single terminal connection to the public switched telephone network (PSTN). However due to differences between the individual PSTNs provided in different countries, the approval does not, of itself, give an unconditional assurance of successful operation on every PSTN network termination point. ## Overview

On 4th August 1998 the European Council Decision regarding the CTR 21 has been published in the Official Journal of the EC. The CTR 21 applies to all non voice terminal equipment with DTMF-dialling which is intended to be connected to the analogue PSTN (Public Switched Telephone Network).

CTR 21 (Common Technical Regulation) for the attachment requirements for connection to the analogue public switched telephone networks of terminal equipment (excluding terminal equipment supporting the voice telephony justified case service) in which network addressing, if provided, is by means of dual tone multi-frequency signalling.

## Network Compatibility Declaration

Statement to be made by the manufacturer to the Notified Body and the vendor: "This declaration will indicate the networks with which the equipment is designed to work and any notified networks with which the equipment may have inter-working difficulties."

Up to now the Notified Body of CETECOM issued several pan-European approvals using CTR 21. The results are Europe's first modems which do not require regulatory approvals in each individual European country.

## Non-Voice Equipment

Answering machines and loud-speaking telephones can be eligible as well as modems, fax machines, auto-dialers and alarm systems. Equipment in which the end-to-end quality of speech is controlled by regulations (e.g. handset telephones and in some countries also cordless telephones) is excluded.
