Nowadays mail servers have become organisation and archiving systems for us. Constant email usage results in Information chaos, even if storage is structured. Archiving any mail server

Compatible with standard mail servers such as Microsoft Exchange®, Hosted Exchange mailboxes, Tobit®, etc. and also all IMAP, SMTP and POP3-compatible mail servers.

Reduce load on mail server/simplify data backup

Increases performance of existing mail server and frees up storage capacities by removing historic emails. Reduces email storage costs permanently through rules-based deletion of unnecessary emails. The UMA drastically simplifies data backups.



Rules-based storage of important email correspondence and attached documents such as offers, invoices, medical records etc.

The UMA Outlook plugin allows comfortable integration of UMA-DMS into the well known Outlook user interface. With the help of an easily reachable search function, you may quickly find emails, documents and pictures. Archived emails will be restored in any file folder, simply by just a single mouse click.

Simple import of emails: with the UMA PST import tool, there is a simple solution for importing emails directly from an MS Outlook PST file or an MS Outlook account into the UMA archive.



Archiving to legal requirements

Time stamp

Securepoint UMA uses qualified time stamps for long-term archiving that are automatically made available to each UMA on a daily basis from a German accredited trust centre. This is particularly significant because many other archiving solutions do not use them. If signed and unsigned emails and documents reach the UMA archive, using qualified time stamps in accordance with legal requirements ensures that the data that was available at a specific point in time has not been tampered with. These time stamps thus ensure that all emails and documents can be provided and archived automatically and with audit compliance.

The probative value retention of the documents and emails is thus saved on a continuous basis using a cryptographic signature. The implementation of the long-term archive follows the requirements of technical guideline 03125 of the Federal Office for Information Security - BSI.
