#### **About This Guide**

This guide provides information on the QNAP TS-x77XU NAS and step-by-step instructions on installing the hardware. It also provides instructions on basic operations and troubleshooting information.

### 2. Product Overview

This chapter provides basic information about the QNAP TS-x77XU NAS.

#### About the TS-x77XU

Equipped with an AMD Ryzen™ processor, the TS-x77XU NAS is a powerful solution for the storage, backup, sharing, and centralized management of your data. Featuring four memory slots that can scale up to 64 GB of memory, as well as a quartet of PCIe expansion card slots, the TS-x77XU adapts to your changing business needs. Each TS-x77XU also features four network ports (two 10GbE SFP+ and two 1GbE RJ45) for increased bandwidth and throughput. The TS-x77XU is able to leverage its AES-NI encryption engine to accelerate the performance of encrypted file transfers.

#### **Drive Installation**


The TS-x77XU is compatible with 3.5-inch and 2.5-inch hard drives, and 2.5-inch solid state drives.


The TS-x77XU supports a maximum of eight SAS expansion units and is compatible with the following models:

- REXP-1210U-RP
- REXP-1220U-RP
- REXP-1610U-RP
- REXP-1620U-RP

To use SAS expansion units, an SAS-12G2E storage expansion card must be installed on the NAS and connected to the expansion units using mini-SAS SFF-8644 cables. You can purchase storage expansion accessories from QNAP or an authorized reseller.



### **Connecting USB Expansion Units**




#### **Hot-swapping Redundant Power Supply Units**

NAS devices with redundant power supply units (PSUs) support hot-swapping.

- 1. Power off the NAS.
- 2. Disconnect the power cord from the electrical outlet and the PSU that you are replacing.
- 3. Firmly press the latch toward the handle and then pull the PSU out.



#### 4. Insert the new PSU.



- **5.** Connect the power cord to the PSU and the electrical outlet.
- **6.** Power on the NAS.
- 7. Enable alerts for PSU failures.
  - **a.** Log on to QTS as administrator.
  - **b.** Go to Control Panel > System > Hardware > General .
  - c. Select Enable Redundant Power Supply Mode.
  - d. Click Apply All.

#### **Installing Expansion Cards**

The NAS supports selected expansion cards, some of which require QNAP PCIe brackets. QNAP-branded expansion cards purchased from the company website are shipped with the brackets necessary to fit all QNAP NAS models.


- Slot 1 will reduce its speed from x8 to x4 if an expansion card is installed in slot 2.
- Slot 3 will reduce its speed from x8 to x4 if an expansion card is installed in slot 4.

#### **Replacing Memory Modules**

The NAS has four memory slots. You can increase the memory capacity of the NAS by upgrading the memory module.

Use only QNAP modules of the same type and capacity to maintain system performance and stability. You can purchase QNAP memory modules from authorized resellers.



#### **Important**

Ensure the following when replacing memory modules:

- When installing only one module, use slot 1.
- When installing two modules, use slots 1 and 3. Ensure that the modules are identical.


· When installing four modules, use slots 1 and 3 for the first pair, and slots 2 and 4 for the second pair. Ensure that each pair uses identical modules.

  - **b.** Insert the module into the slot.

- **c.** Verify that the metal connectors are completely inserted into the slot.
- **d.** Carefully press down on the module until the retention clips lock the module into place.





  - $\textbf{b.} \ \ \textbf{Go to Control Panel} \textbf{> System > System Status > Hardware Information} \ .$
  - **c.** Check the value for **Total memory**.

### 5. Troubleshooting

This chapter describes basic troubleshooting information.

#### Forcing Qfinder Pro or myQNAPcloud to Locate the NAS

If Qfinder Pro or myQNAPcloud is unable to locate the NAS during QTS installation, the drives or data may be faulty.

- 1. Power off the NAS.
- 2. Remove all drives.
- 3. Power on the NAS.
- 4. Locate the NAS using Qfinder Pro or myQNAPcloud.
- 5. Reinsert the drives.
- 6. Continue with the QTS installation.

#### **Hot-swapping Failed Drives**

The NAS supports hot-swapping of drives in the following situations:

- · RAID 1: One member drive fails
- RAID 5: One member drive fails
- · RAID 6: One or two member drives fail
- 1. Log on to QTS.
- 2. Go to Main Menu > Storage Manager > Storage > Disks/VJBOD.
- 3. Locate the failed drive.
- 4. Prepare a new hard drive with a capacity that is the same as or larger than the failed hard drive.
- **5.** Remove the failed drive from the NAS.
- 6. Wait for 20 seconds or until the NAS beeps twice.
- 7. Remove the failed drive from the drive tray.
- **8.** Insert the new drive into the drive tray.
- **9.** Install the new drive. The NAS beeps twice.
- 10. Go to Main Menu > Storage Manager > Storage Space.
- 11. Locate the volume that contains the new drive and then verify that the status is Rebuilding.

# **Recovering Unintentionally Removed Healthy Drives**

The NAS supports exclusive RAID recovery technology to recover failed RAID disk volumes from unintentional disconnection or removal of drives. Users can recover an inactive RAID 1, RAID 5, or RAID 6 volume to degraded mode, or an inactive RAID 0 and JBOD configuration to normal.
