1 End User License Agreement (EULA)

IT IS A LEGAL AGREEMENT BETWEEN (A) THE PERSON ACCEPTING THIS EULA EITHER AS AN INDIVIDUAL OR SOMEONE AUTHORIZED TO ACCEPT THIS EULA ON BEHALF OF A SINGLE ENTITY (IN EITHER CASE, "YOU") AND (B) HP INC. THIS EULA GOVERNS YOUR USE OF THIS APPLICATION INSTALLED ON YOUR DESIGNJET OR PAGEWIDE XL PRINTER. This Application automatically collects usage data from any printers registered with the Partner Link program by you and/or your HP Authorized Reseller. In addition, as part of the Application set-up process, you will be required to provide contact information (name and email). All the data is collected and used in accordance with the Privacy Notice section below. If you wish to stop the Application from automatically collecting printer data from your registered printer, then you must have the Application de-installed.

Privacy Notice

HP Inc. (HP) respects your privacy and is committed to protecting it. HP provides this Privacy Notice to inform you that, when installed on printers, this Application enables your printer to periodically send printer configuration and usage information to HP over the internet. Information sent to HP is used to provide the Partner Link program, including providing customized analysis of your printer usage and calculating aggregate usage statistics. The information is also used to improve the performance of products and services.

For any printers registered to use the Partner Link PPU service, HP collects printer status and usage data, and other printer-specific data. Printer-specific data as well as your contact information will also be shared with your specified HP authorized Reseller in order for them to better manage your account, respond to your HP DesignJet or PageWide XL ink supplies needs and help manage your service delivery. This data may be shared with other HP DesignJet or PageWide XL printer and supplies entities, possibly overseas, to enable this Application. The list below specifies the type of information that HP will collect:

- Product name and model number
- Serial number
- Firmware version
- Quantity, brand, and type of ink used

- Quantity and type of media (paper) used
- Printer status data for print engine, printhead, ink cartridge, and media
- Printer usage data including printer error data
- Print job information (job ID, print size, print quality, printing time, number of pages, etc.)
- IP and MAC addresses
- Data provided by Customer and Reseller:
 - Mandatory: Company name, user email, user name and last name
 - Optional: User phone, company location, company contract ID

HP will maintain the privacy of any personal data collected, in accordance with the [HP Privacy Statement](#). To the extent that HP is processing any personal data to which it has access on behalf of your customers, HP's [Customer Data Processing Addendum](#) shall apply. Terms of Use
