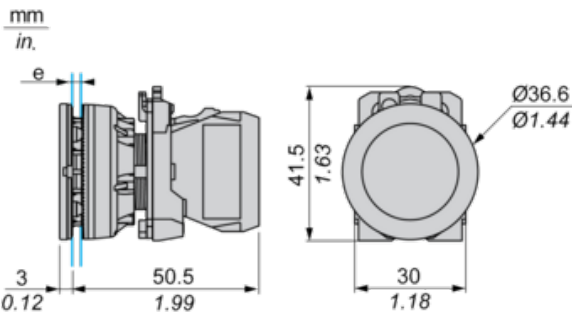

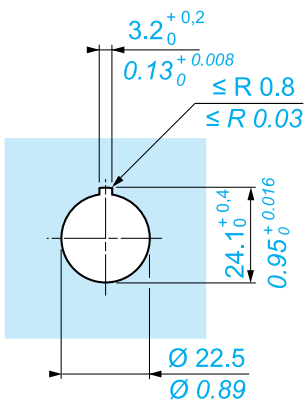
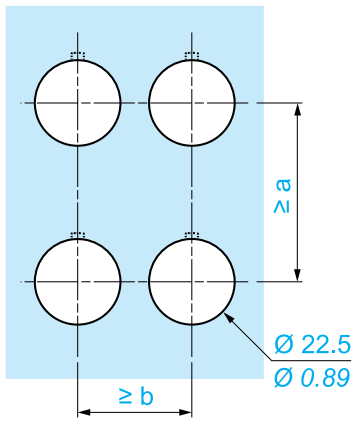
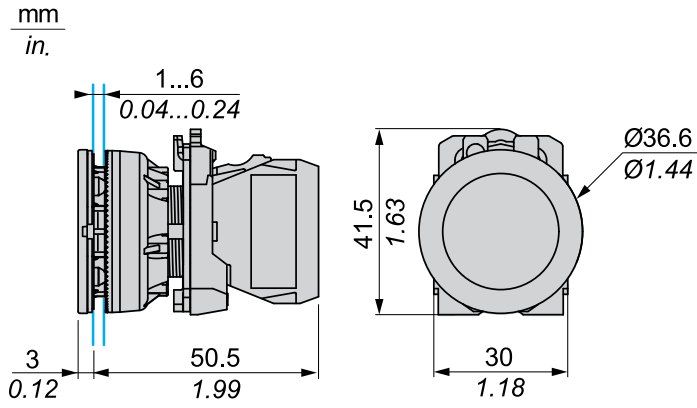
Possible location
